## ORDINANCE NO. 313

AN ORDINANCE AMENDING SECTION 2.08.080-ORDER OF BUSINESS AND ADDING SECTION 2.08.085-DEFINITIONS, TO CHAPTER 2.08-COUNCIL MEETINGS, TITLE 2 OF THE PALMER MUNICIPAL CODE.

THE CITY OF PALMER, ALASKA, ORDAINS:

Section 1. Classification. This ordinance shall be of a permanent nature and shall become a part of the City of Palmer Code of Ordinances.

Section 2. Severability. If any provisions of this ordinance, or any application thereof to any person or circumstance is held invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

<u>Section 3</u>. Section 2.08.080 <u>Order of Business</u> is hereby amended as follows:

2.08.080 Order of business. At every regular meeting of the city council the order of business shall be as follows:

- Α. Call to order;
- Β. Roll call;
- C. Approval of Agenda;
- Pledge of allegiance; D.
- Minutes of previous meetings; Ε.
- F. Consent agenda;
- G. Communications and appearance requests;
- Η. Audience participation;
- Ι. Hearings, ordinances and resolutions;
- J. Bids:
- Κ. Old business;
- L.
- New business; City manager's report; М.
- Borough representative's report; Ν.
- Audience participation; 0.
- Ρ. Council comments;
- Q. Adjournment.

Section 4. Section 2.08.085 Definitions is hereby added as follows:

2.08.085 Definitions. A. <u>Consent Agenda</u>: Items of a routine nature, not requiring any discussion or debate. If any councilmember desires an item on the consent agenda removed for discussion or debate, he/she should so indicate at the time the agenda is approved and the mayor or mayor protem will place it at the appropriate place on the agenda.

Β. Communication and Appearance Requests: Requests shall be in writing, submitted to the city manager, and may be assigned an appropriate place on the agenda by him. All presentations to the council shall be limited to five minutes, unless otherwise ordered by the council.

Audience Participation: All presentations to the council shall C. be limited to two minutes per person and also limited to a total time of not more than thirty minutes.

<u>Section 5</u>. Publication and Effective Date. This ordinance shall become effective immediately upon its adoption and publication and shall be by posting a copy hereof on the City Hall bulletin board for a period of ten (10) days following its adoption, and it shall be published by being printed and included in the Palmer Municipal Code at its next regular supplementation and printing. A notice of public hearing shall be given by such posting at least five (5) days before final passage.
