

## CITY OF PALMER, ALASKA

## ORDINANCE NO. 402

AN ORDINANCE AMENDING SECTION 13.12.140 CHARGES DESIGNATED OF CHAPTER 13.12, WASTEWATER COLLECTION AND TREATMENT OF THE PALMER MUNICIPAL CODE.

THE CITY OF PALMER, ALASKA, ORDAINS:

Section 1. Classification. This ordinance shall be of a permanent nature and shall become a part of the City of Palmer Code of Ordinances.

Section 2. Severability. If any provisions of this ordinance, or any application thereof to any person or circumstance is held invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

Section 3. Section 13.12.140 of Chapter 13.12 of the Palmer Municipal Code is hereby amended as follows:

13.12.140 Charges designated.

A. Permit filing and review	\$50.00
B. Connection fee - sewer	40.00
C. Deposit - water & sewer	50.00
D. Treatment rates:	
<u>Gallons</u>	<u>Sewer</u>
0--5,000	\$ 8.25
Over 5,001	8.25 plus 0.165 per 100 gallons
Effective 10/01/89	
0-5000	\$ 9.00
Over 5,001	9.00 plus 0.18 per 100 gallons
Effective 10/01/90	

E. The charges, fees and rates as listed above shall be reviewed annually at the time of the city audit by the city manager. At any time that the city manager finds that the charges, fees, and/or rates do not reflect actual costs to the city, the manager may adjust the rates to more realistically represent actual costs subject to ratification of the city council.

F. The rates as presented are for all wastes being delivered to the POTW. There shall be extra charges levied for any waste with pollutant strength in excess of those stated in Section 13.12.070. Those charges shall be determined by the city manager. Any waste with a pollutant strength in excess of those stated in Section 13.12.070 must be pretreated at owner's expense prior to entering the city sewerage system.

Section 4. Publication and Effective Date. This ordinance shall become effective October 1, 1989. Publication shall be by posting a copy hereof on the City Hall bulletin board for a period of ten (10) days following its adoption, and further it shall be published by being printed and included in the Palmer Municipal Code at its next regular supplementation and printing. A notice of public hearing shall be given by such posting at least five (5) days before final passage.
