

RESOLUTION NO. 17

RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF PALMER, ALASKA

It was moved by Mr. Hagen and seconded by Mr. Sandvik that: Mr. Head, having been appointed by the Mayor as City Magistrate, it is now moved that his appointment be confirmed by the City Council and in the event of Mr. Head's absence, Dorothy Saxton serve as City Magistrate. Carried unanimously.

It was moved by Allan Mick and seconded by Steve Ward that the Council accept Mr. Hagen's offer that his basement space in the theater be used as the City Jail, such space to be maintained by the City untill May 1st, 1952. This was carried unanimously.

It was suggested that the City Council inform Bernard Bouwens to repair the jail for accupancy.

It was announced that the Mayor appointed Bernard R. Bouwens to the position of Police Chief of the City of Palmer as of September 15, 1951 at six hundred (\$600.00) dollars a month in accordance with the agreement of September 15, 1951.

It was then moved by Allan Mick and seconded by Lloyd Severns that the appointment of Bernard R. Bouwens having been made as Police Chief that his appointment now be confirmed by the City Council as of September 15, 1951 per agreement of September 15, 1951. This was carried unanimously.

RESOLUTION NO. 18

RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF PALMER, ALASKA

It was moved by Mr. Hagen and seconded by Steve Ward that: Be it hereby resolved that an emergency exists, that the rules be, and hereby are, suspended to permit consideration of the adoption by one reading of an ordinance prohibiting solicitation in business and residential area. Carried unanimously.

There then followed a reading of the ordinance prohibiting solicitation in business and residential areas.

It was moved by Lloyd Severns and seconded by Chet Sandvik that the Council adopt Ordinance No. 13 made on one reading prohibiting solicitation in business and residential areas. This was carried unanimously.

Mr. Maynard Sands then presented his prepared report to the City Council. This report consisted of Mr. Sands proposals of a telephone system in Palmer.

It was suggested by Mr. Hagen that the Council await further proposals from other interested sources in the matter of the telephone system establishment and that the Council make no decision as yet.

It was suggested by Mr. Severns that a special Council meeting be called in order to arrive at conclusions in regard to what the City would want in the way of a telephone system. It was agreed that a special, closed meeting will take place Tuesday, September 25, 1951 at which time the Council will look into the matter. Mr. Carl Meier will contact Major Krueger, second in command of ACS and invite him to this Council meeting.

There then followed the first reading of Ordinance No. 14 providing for licenses, permits, and taxation. The committee to study the fee schedule for this ordinance consists of Mr. Brown and Mr. Severns.
