

RESOLUTION NO. 58

RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF PALMER, ALASKA

AUTHORIZING THE EXECUTION OF AN AGREEMENT FOR CONSTRUCTION OF WATER WORKS, AND EXTENSIONS AND IMPROVEMENTS TO MUNICIPAL WATER SYSTEM.

WHEREAS, under the terms of the Alaska Public Works Act, approved August 24, 1949 (63 Stat. 627, 48 U. S. C. Secs. 486-486j) the City of Palmer hereinafter called the Purchaser, has hereto fore applied to the UNITED STATES OF AMERICA FOR a public works project consisting of: Construction of waterworks, and extensions and improvements to municipal water system;

WHEREAS, the United States has allotted the sum of Six Hundred Seventy Five Thousand Dollars (\$675,000) for the construction of water works, and extensions and improvements to municipal water system under the terms of the said Alaska Public Works Act; and

WHEREAS, the City Council of the Purchaser has received from the United States of America a proposed Project Construction and Sales Agreement under and by virtue of the terms of which the United States of America undertakes to provide the public works project above described, and to transfer said public works project to the Purchaser in consideration of the Purchaser's agreement to operate and maintain the public works project at its own expense and to pay to the United States of America for such public works project the sum of Three Hundred Thirty Seven Thousand Five Hundred Dollars (\$334,500) with simple interest at two per cent (2%) as specified in said Project Construction and Sales Agreement; and

WHEREAS, the Purchaser considers it to be in the public interest and to its benefit to execute such project Construction and Sales Agreement,

NOW, THEREFORE, BE IT ORDAINED BY THE PURCHASER AS FOLLOWS:

1. That the Purchaser hereby approves and agrees to the terms of the Project Construction and Sales Agreement proposed by the United States of America under Project No. Aaa. 50-A127, which Agreement read as follows:

(Project Construction & Sales Agreement on File)

2. That the Mayor and the City Clerk are hereby authorized to execute said Project Construction and Sales Agreement in triplicate on behalf of the Purchaser and to affix thereto the seal of said Purchaser.
3. That the City Clerk is hereby authorized to transmit said executed Agreement and certified copies of this Resolution and of the Minutes of the meeting of the City Council of the Purchaser at which this Resolution is adopted to the Office of the District Director, Alaska Branch of Public Works Division of the Office of Territories, Juneau, Alaska, and to take such other action as may be necessary to enable the Purchaser to cooperate to the fullest extent with the United States of America in the construction of said Project.
