RESOLVED FURTHER that endorsements for deposit be made by the written or stamped endorsement of this corporation without designation of the person or persons making the endorsement.


RESOLVED FURTHER that the aforesaid persons are authorized and empowered to make, collect, discount, negotiate, endorse and assign in the corporate name, all checks, drafts, notes and other paper payable to or by this corporation; to make and enter into any and all agreements including, but not limited to, Special Depository Agreements and Arrangements with reference to the manner in which, the conditions under which, or the purposes for which funds, checks or other items of this corporation may be deposited, collected or withdrawn; to delegate to others such authority in connection with or pertaining to the establishment of any account or the transaction of any banking business with said Bank as they may consider proper.

RESOLVED FURTHER that the authority hereby conferred upon the above named persons shall be and remain in full force and effect until a new corporate resolution shall have been delivered to and received by the Bank at the branch or office where such accounts are maintained.

RESOLVED FURTHER that there shall be no obligation on the part of said bank to see to the application of funds in any case whatsoever.
