CITY OF PALMER, ALASKA RESOLUTION NO. 191

A RESOLUTION PROVIDING FOR THE SUBMISSION TO THE QUALIFIED ELECTORS OF THE CITY OF PALMER, ALASKA, THE QUESTION OF ACQUIRING AND CONSTRUCTING A PUBLIC IMPROVEMENT MANUFACTURING AND PROCESSING FACILITY WITHIN THE SAID CITY AND THE ISSUANCE OF FOUR HUNDRED FIFTY THOUSAND DOLLARS (\$450,000.00) OF GENERAL OBLIGATION BONDS OF SAID CITY TO DEFRAY THE COST OF SAID PUBLIC IMPROVEMENT AT A SPECIAL ELECTION TO BE HELD IN AND FOR THE CITY OF PALMER ON THE 27th DAY OF MAY, 1969.

BE IT RESOLVED by the City Council of the City of Palmer, Alaska:

Section 1. It is hereby determined to be in the interest of the City of Palmer to issue public improvement manufacturing facility general obligation bonds in an amount not to exceed Four Hundred Fifty Thousand Dollars (\$450,000.00) under a 20-year improvement program providing for the acquisition of the site and the construction of a manufacturing and processing facility at a location to be determined within the City of Palmer.

Section 2. That there be borrowed by, for and on behalf of said City of Palmer the sum of Four Hundred Fifty Thousand Dollars (\$450,000.00) therefor, payable in general obligation bonds of the City of Palmer. Said bonds shall mature within twenty years from the date of issue and bear interest at the legal rate.

That a special election be held on the 27th day of May, 1969, in and Section 3. for the City of Palmer and at said election the following proposition shall be submitted to the qualified electors of the City of Palmer:

PROPOSITION NO. 1

Shall the City of Palmer, Alaska, issue general obligation bonds in an amount not to exceed Four Hundred Fifty Thousand Dollars (\$450,000.00) for the following purpose: Under a 20-year improvement program providing for the purchase of a site and the construction of a manufacturing and processing facility within the City of Palmer. All said general obligation bonds shall mature within twenty years from the date of issue and bear interest at a legal rate.

Section 4. The foregoing proposition shall be printed on one ballot and shall consist of a statement of the proposition set forth in Section 3 with the following added to the proposition:

Section 5. The qualifications for electors at said special election are as follows:

- (a)
- They must be at least 19 years of age.
 They must be citizens of the United States and for at least one year just preceding said election residents of the State of Alaska, and for at least thirty days just preceding the election residents of the election district in which the city is located.
- They must be able to speak or read the English language as prescribed by law.
- They must not be barred from voting by any other provision of law.
- They must be registered in the manner prescribed by law.
- They must be persons whose names appear on the last tax assessment roll for the City of Palmer for purposes of municipal taxation.

Section 6. Registration shall be required as a qualification of the voters in this special election. The registration book will be opened daily at the office of the City Clerk, Registrar, at the City Hall, Palmer, Alaska, from 9:00 a.m. until 5:00 p.m. daily except Saturdays, Sundays and Holidays, except that the City Clerk,

Registrar, may extend registration until 10:00 p.m. during the week prior to the closing of registration. Registration shall be closed ten days preceding said special election.

Section 7. A duplicate registration index shall be furnished by the City Clerk, Registrar, to the judges and clerks of election at each precinct. Notices shall be published once a week until ten (10) days before the election. It shall state the time of closing of registration and shall be published in a Palmer newspaper of general circulation to be selected by the City Clerk, Registrar.

Section 8. The polling places within the City are designated as follows:

Precinct No. 1: For those qualified voters living within the area of the corporate limits bounded by the following described line:
